### **OKFS LIABILITY WAIVER:**

IN CONSIDERATION of being permitted to compete, officiate, observe, work for, or participate in any way in the EVENT(S) EACH OF THE UNDERSIGNED, for themselves, their personal representatives, heirs, and next to kin:

HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the promoters, participants, associations, sanctioning organizations or any subdivision thereof, operators, owners, officials, craft owners, rescue personnel, any persons, promoters, sponsors, advertisers, owners and lessees of premises used to conduct the EVENT(S), premises and event inspectors, surveyors, underwriters, consultants and others who give recommendations, directions, or instructions or engage in risk evaluation or loss control activities regarding the premises or EVENT(S) and each of them, their directors, officers, agents, employees and affiliates, all for the purpose herein referred to as "Releasees," FROM ALL LIABILITY TO THE UNDERSIGNED, his/her personal representatives, assigns, heirs, and next of kin FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THEREFORE ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN DEATH OF THE UNDERSIGNED ARISING OUT OF OR RELATED TO THE EVENT(S), WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.

HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the Releasees and each of them FROM ANY LOSS, LIABILITY, DAMAGE, OR COST they may incur arising out of or related to the EVENT(S) WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.

HEREBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE arising out of or related to the EVENT(S) whether caused by the NEGLIGENCE OF RELEASEES or otherwise.

HEREBY acknowledges that THE ACTIVITIES OF THE EVENT(S) ARE VERY DANGEROUS and involve the risk of serious injury and/or death and/or property damage. Each of THE UNDERSIGNED, also expressly acknowledges that INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASEES.

HEREBY agrees that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by the Releasees, INCLUDING NEGLIGENT RESCUE OPERATIONS and is intended to be as broad and inclusive as is permitted by the laws of the Province in which the Event(s) is/are conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.


### **AGREEMENT:**

- **2.** I AGREE TO ABIDE BY THE 'TOURNAMENT RULES' A COPY OF WHICH I HAVE BEEN PROVIDED WITH AND I HAVE READ AND UNDERSTAND.
- 3. I AGREE TO COMPLY WITH ALL FISHING REGULATIONS FOR ONTARIO.
- 4. I HAVE READ THE KAYAK TOURNAMENT LIABILITY WAIVER AND SIGNED IT.
- **5.** I AGREE THAT TOURNAMENT SPONSORS, AFFILIATES AND ORGANIZERS, ALONG WITH THE TOURNEY ITSELF, ACCEPT NO RESPONSIBILITY FOR INJURY OR LOSS DURING THE TOURNEY OR ANY EVENTS CONNECTED WITH THE TOURNEY.

### **Rules and Regulations for OKFS Tournaments:**

- 1. Tournament fishing must be within the specified times. Fish caught outside this time will be disqualified.
- 2. Fishing must be done from a single person kayak the entire duration of the tournament. This watercraft must launch and fish within specified boundaries each day. See maps.
- 3. All fishing must comply with provincial, local lake and Ministry of Natural Resources updated regulations. These can be found on their website http://www.mnr.gov.on.ca/MNR\_E001334.pdf
- 4. All fish eligible for entry must be of Bass species. The limit per day is three of either species. The total length of each fish will be added together to give the final tournament standings. Total length is the measurement from the tip of the snout to the tip of the tail (with the tail collapsed) in order to get the longest possible length measurement.

- 5. At least one clear, detailed, color photo showing full length side view of fish must accompany each entry. The fish should fill as much of the frame of the photograph as possible. Your picture should include the approved and numbered measurement device alongside the fish to verify length. Both the fish and device should be the same distance from the camera. The photos must be clear enough to easily tell the length of the fish. Judges have the authority to make each call on a case to case basis.
- 6. All cameras/cards must be handed to judges before the cut off time each day to qualify the photos
- 7. As guests of the host facilities and surrounding areas we must act in a responsible manner both on and off the water. Failure to comply may result in disgualification and possible removal from campground or host site.
